Every two years, your Illinois CSR license comes up for renewal and, with that, the requirement of 10 hours of continuing education. As a service to our members, every two years ILCRA hosts a one-day Marathon session, where attendees may receive all 10 hours of CEUs in one very long day. This year the session was in Lombard.

Our Executive Director (and NCRA Interim Executive Director) Dave Wenhold started off the day with a session about body language, which I've seen a few times and continue to benefit from whenever I've seen it.

# of students into school and graduating them in two years.

She discussed setting and meeting goals, and how Project Steno is bringing the Steno A to Z program to our military bases to help find new candidates for stenotype training.

Attendees were also treated to seminars about modern slang, career transitioning, reaching for the next level in stenotype skill, and CART captioning from the perspective of the deaf/hard-of-hearing consumer.

We held an ILCRA Town Hall meeting, which will be held again in Springfield this September during our annual convention.

One of two major subjects we discussed were an update on SB 2128, the Voice-Writer Reporters Act, which will add voice writing as a certified method of reporting. Voice writers will need to pass the exact same test that we do in order to obtain the Illinois CSR license. As of this writing, it has passed the Illinois *continued on page 4*

Senate unanimously and is headed for the House.

We will continue to update our membership on the status of this bill as events happen.


The second subject was the fight against digital reporting, which affects every one of us in Illinois, as well as each board member. We on the board are full-time working reporters as well, so absolutely we are fighting the fight as well.

NCRA is collecting confirmed reports of digital audio recording failures, and they have requested each

individual state submit these reports to them, so we can aggregate evidence to help us counter common arguments that digital reporting companies make. If you hear of such failures in Illinois, please submit them to Region 2 Representative-Official Kim Cottrell. Her contact information is in the sidebar in this newsletter.

If you are on Facebook, we recently published a lovely graphic illustrating the difference between stenotype reporting and digital reporting, which was developed by Region 1 Representative-Freelance Mary Ann Casale. <u>This graphic is also on our website</u>, so feel free to download it, share it, or print it out and include it with your marketing materials.

Hall, such as the concept of an outreach program to the Bar and legal professionals. Ideas, however, aren't helpful unless we have enough people to implement them.





# **Mock Trial**

From the very first day I became a board member, I've said it was up to us to promote our profession just about any way it takes to put what we do out in front of young people. I have to thank one of my county's state's attorney, Jamie Friye, for another opportunity.

Jamie organizes a mock trial for Law Day in Adams County for elementary school students so that they can get an idea of what an actual trial might be like. The judge, attorneys, court reporter, parties, and witnesses are people from the local Bar Association and courthouse personnel who volunteer to be actors in the mock trial. I was fortunate enough this year to be the court reporter during these proceedings.

I would not want to swear that the 45 minutes of "trial" was conducted with somberness and straight faces. We had fun. But the best learning goes on when kids are having fun. The actors tried to play their parts with stern looks, but there were a lot of antics and laughing along the way.

Afterwards, all of our actors, none of which will ever win an Oscar, introduced themselves to the students, briefly explaining their role in the judicial process. When it was my turn, I shared with them how wonderful a career in court reporting is and that there is a shortage of court reporters all across the country.

Jamie then asked if there were

any questions from the students. I was pleased that a couple of students had questions for me and wanted to know more about "that little machine." When all the questions were asked and answered and as the students were exiting the building to continue with Law Day activities, they formed a line to look at my machine.





What really surprised me was the number of questions that came from the kids. I'm sure most of you have heard these questions: How do you do that? How do you know what keys to use when there's nothing on them? How fast do you have to be?

I told them about court reporting school, speed building, and practice. When I told them a court reporter has to attain a speed of at least 225 wpm, there were looks of disbelief that anyone could ever move their fingers that fast. I tried to encourage them and told them through court reporting school and with practice, anything was possible if it's something they really want.

I feel like it was a good experience for the students as well as me. I'm proud to be a court reporter and hope that I was able to spark an interest in these young students. Take a chance to speak to a member of your local Bar Association about participating in a mock trial or seeing who could organize one. It's another chance to provide young people with an opportunity to not only hear about what we do but actually see us doing it.

### We Need Your Help to Gather Data

NCRA's STRONG Task Force is gathering data in order to raise awareness about the dangers and pitfalls of digital recording usage. Each state has designated a person to compile all the data for their state to provide to NCRA. For Illinois, I'm that person.

All the courthouses in my district are electronically recorded and, unfortunately, there are many proceedings that take place with no court reporter present. When I am assigned to prepare a transcript from one of these electronically recorded proceedings, there are many times I am unable to hear or understand what is being said.

This can be due to a number of factors including rustling paper, doors slamming, simultaneous speaking, or someone speaking too softly or too far away from a microphone. There are also times when someone is mumbling or speaking so fast that it is very difficult, if not impossible, to determine what is being said. In these cases, I have to insert a parenthetical, usually "indiscernible," and move on.

That's my experience as an official court reporter. I haven't had any first-hand experience with digital reporters/recorders, but I imagine it would be similar.

As a board representing all court reporters across the state, we're working hard to combat this threat. However, it can't happen without your help, and I truly need your assistance.

Anytime you come across electronic recordings that leave you scratching your heads and muttering one of those phrases I can't use here, please send me the audio clip and whatever information you can provide to kimrcottrell@icloud.com. Please reach out to me if you have any questions. The more examples we can collect, the stronger our position becomes.

It doesn't matter if you are a freelance writer or in the courtroom. We're all working together to ensure a future and building respect for ourselves and the job we do.

# **I Went to Boot Camp and Survived!**

#### Bring on the HEAT!

Every so often we get caught in a situation where you just don't know what you're getting into. For me, that was last month as I headed off to my first-ever NCRA Leadership and Legislative Boot Camp held in Washington, D.C.

We were all divided into groups which would be tasked with a scenario of asking members of Congress for reauthorization of a bill. I had no idea what that meant, but okay. Also, everyone in my group was a stranger to me. Out of my comfort zone. And by this, I mean "what is the first plane I can get on to take me home" panic mode. Little did I know that by the end of the boot camp, these would be some of my favorite people.

Most of the first day was spent pretty much like any seminar you might attend: listening to presenters speak and having discussion on different topics. Some of the topics included Politics 101 and the issue of electronic/digital recording. There were a lot of questions and answers throughout the day, which was great. I don't think a single question went unanswered. I thought, No problem. I've got this.

Then towards what I thought would be the end of the day, ILCRA's Executive Director and NCRA's Interim CEO and Executive Director, Dave Wenhold, introduced the scenario and instructed everyone how to develop the game plan for the meetings and hearings we would participate in the next day.

What's this you say?! You mean I'm going to have to participate actively? I can't just sit back, listen, and learn? Talk about being out of your comfort zone! This was way beyond that for me. What gate is my plane leaving from?

Bring on the HEAT: Higher Education Action Team. This is what my group decided to name our task force. We all worked well into the evening that first night



developing our plan, including characters. My task force consisted of Councilwoman Frugal; a one-handed, deaf college student; a Spanish mom with a deaf child; Harvey Wallbanger, an elderly and late-deafened gentleman; a representative from the office of emergency preparedness; Mary Poppins, a representative of teachers; and a chopper pilot and hard-of-hearing veteran. Each of us created a backstory of why accurate captioning is so important.

All the next day was spent meeting separately with nine different role players of "members of Congress" and other professions (who were actually some of NCRA's Board Members) to gain their support for the reauthorization of the Higher Education Act ("HEA");



specifically, the training for realtime writers grant. After each meeting, we were able to have a discussion on how we can improve and things to remember to say and do. After all the individual meetings, we also presented at a committee hearing in front of four role players. During each meeting and at the committee hearing, the Board Members were tough on us and asked questions we weren't always prepared for.

The last day of Boot Camp was the BIG day,

the day we went to Capitol Hill to speak with the actual members of Congress from each of the states. Again, beyond my comfort zone. To say I was nervous would be an understatement. While I was not fortunate enough to be able to meet with the members themselves, I was able to meet with their staff and discuss the reauthorization of HEA and why it's so important. I met with staffers in the offices of Representative Darin LaHood, Representative Tammy Duckworth, and Senator Richard Durbin. Each office was very welcoming and treated me as if my concerns were also important to them. I received positive feedback and came away feeling they would be supporting the reauthorization of the HEA training for realtime writers grant.

I am so grateful I was able to attend Boot Camp. I am armed with the tools I need and have gained the confidence and courage to be able to approach city- and state-level legislators to discuss important issues in court reporting. I am able to help to lead our profession in the right direction. And the friendships forged during the intensive three days of Boot Camp will be everlasting. If you ever get an opportunity yourself to attend Boot Camp, I would highly encourage it. Step out of your zone. Take a chance. You'll surprise yourself and have some fun along the way.
