## CSR Exam to Allow Paperless Transcription

he CSR examination has been changed to allow candidates to use paperless writers and/or Computer Aided Transcription (CAT) software during this test, but only if you indicate that you plan to use your own portable computer for transcription when you complete the CTS online application to schedule this test.

Candidates who do not indicate in the CTS online application that they plan to use their own portable computers for transcription will be required to use an onsite computer for transcription and will not be allowed to use a paperless transcription machine.

CAT software and support for paperless writers is not available in onsite computers provided by the test center.

All candidates must bring and surrender a USB drive from which their transcription can be printed by a CTS proctor. The USB drive must then be submitted with the printed transcript.



## TEMP FILES: TO DELETE OR NOT TO DELETE?

Q. Is it safe to delete everything in my Temporary files folder? I notice that some of the files are several years old, while others are only a couple of days old. Can I delete everything and wipe the slate clean?

A. C:\WINDOWS\TEMP is a folder set aside for files that a program creates while it is running. If you open a document in Microsoft Word, for example, the program creates a number of temporary files to keep track of editing changes so you can undo them later, if necessary.

It's safe to delete everything in your C:\WINDOWS\TEMP folder, except files that display the current date, because those might be in use or needed while a program is being used. Anything older than the current date is fair game. To delete your temporary files, using Windows Explorer (Windows Key + E), navigate to your C:\WINDOWS\TEMP folder and click View > Details. Click the "Modified" or "Date Modified" column headings to sort the files by date.

Select files that are dated before the current date by clicking the first file you want to delete, holding down the SHIFT key and clicking the last file. All files between your first and last selections will be highlighted. If you need to delete non-contiguous files, meaning files incapable of spreading disease — no, wait, that would be noncontagious files. Sorry. If you want to delete files that aren't next to each other, hold down the CTRL key, instead of the SHIFT key, and click only the files you want to delete. Once your selected files are highlighted, press the DELete key.

# Q. I bought an external drive that requires a USB 2.0 port. I'm not sure what my computer has? How can I tell?

A. A quick visit to your Device Manager will let you know if you have USB 2.0 or USB 1.x, so right-click My Computer > Properties > Hardware tab > Device Manager button.

Scroll down and click the little plus (+) sign in front of "Universal Serial Bus Controllers." Look for "Standard Enhanced PCI to USB Host Controller." The wording may vary, but the key word is "Enhanced." If it's "Enhanced," it's USB 2.0; If it's not, then it's USB 1.x. As a low-tech alternative, plug in your device and see what happens. At best, it will work; at worst, it won't.

# Q. I bought a new printer so I need to uninstall my old one. Can you explain how to do that? I'm using Windows XP, if that matters.

A. To remove your old printer, click Start > Printers and Faxes, then right-click your old printer icon and select Delete. You'll be asked to confirm the deletion.

Removing your old printer may not remove extra drivers and/or support software, so you may need to remove those items manually. To do that, go to your Control Panel > Add/Remove Programs, and look through the list for anything that relates to your old printer by name. If you find something, click to select it, then click Remove. If anything fails to budge, use the free Revo Uninstaller (www.revouninstaller.com).



## **NCRA** NewsFlash

## U.S. NEWS & WORLD REPORT LISTS COURT REPORTER AS ONE OF THE 50 BEST CAREERS IN 2010

U.S. News & World Report cites the U.S. Bureau of Labor Statistics as projecting that jobs in the court reporting field will grow 18 percent between 2008 and 2018. It attributes this above-average growth to the "growing need for live television captioning and translating services for the hearing impaired." In addition to growth in jobs, the article notes certification as a method for advancement in the profession.

## FEDERAL COURTS, STATE PRISON SATISFIED WITH E-FILING FOR INMATES


The U.S. District Court for the Central District of Illinois has instituted e-filing for use in processing prisoner petitions. The program allows prison library staff to scan the inmates' documents into a PDF format that is then e-mailed to the court for e-filing. The e-filing system mostly handles lawsuits challenging an inmate's conditions of confinement or other alleged civil rights violations, but the court has also received other types of actions via e-filing.

#### PANEL RECOMMENDS PLAN FOR COURT-ROOM CAMERAS

A committee appointed by the South Dakota Supreme Court has recommended that cameras and other recording devices be allowed in the state's trial courts. The Supreme Court will take the recommendations into consideration as they consider whether to change the rules dealing with cameras in trial courts.

## GADGETS AND GIZMOS SECTION ADDED TO FORUM

NCRA added a new section to the NCRA Online Forum. The new section, Gadgets, Gizmos and Non-CAT Software, which is under the Profession section, is devoted to discussions about laptops, printers, WiFi, firewalls, antivirus programs, and other gizmos, as well as non-CAT hardware and software. # Attention ILCRA Speed Contest and Realtime Contest Participants

here are some changes to this year's Illinois Court Reporting Association annual speed and realtime contests.

As most of you know or will know very soon, the annual convention for NCRA will be held in Chicago this year from August 4 through 8. Therefore, Illinois will not hold a state convention and will not conduct a speed contest for Illinois participants only.

What does this mean to you? It means that Illinois will have both a speed and a realtime contest, but it will be in conjunction with NCRA at the national convention in Chicago.

In order to be considered for the Illinois contest(s), you must register for the national contest(s), pay the appropriate NCRA fee(s), and also register with ILCRA and pay an additional fee of \$25 to ILCRA. (See form below.)

The Illinois standard for the two-voice portion of the speed contest is slightly lower than NCRA's. Illinois participants will be graded according to Illinois speeds for Illinois-only winning, placing, and qualifying. Your test(s), however, will be graded according to NCRA standards for national consideration in those categories. Illinois only has a 180 Literary for the realtime, therefore, Illinois participants will be judged only on the 180 Literary for qualifying, winning, and placing for Illinois only. [The complete rules for ILCRA's speed and realtime contests appear on pages 17–18.]

Illinois results will not be announced at the NCRA awards luncheon, but contestants can stop by the Illinois booth in the vendor area to check on the results and pick up the medals or the trophy. Qualifying Illinois certificates will be sent to all who meet the requirements.

## **ILCRA 2010 Speed & Realtime Contests Regulations**

## GARY L. SONNTAG MEMORIAL SPEED CONTEST:

- 1. Eligibility: Any writer of shorthand (pen or machine) who is a member in good standing of NCRA and ILCRA is eligible.
- 2. Tests: Five-minute tests will be dictated as follows:

TEST	SPEED	TRANSCRIPTION

Literary	220 wpm	90 minutes
Legal Opinion	230 wpm	90 minutes
Testimony	270 wpm	90 minutes

- 3. Number of transcriptions permitted: One of each take.
- 4. Professionalism barred: Contestants must give to the ILCRA Board satisfactory assurance that they have not received, directly or indirectly, any remuneration or promise of remuneration of whatever character for entering or winning any part of this contest.
- 5. Entry fee: \$25.
- 6. Pre-registration: All contestants must submit their contest registration forms at least 30 days prior to the contest to ensure availability of adequate transcription facilities and familiarity with contest rules.
- 7. Awards: The contestant who qualifies on the three above tests with the highest average for the three shall be awarded the first-place plaque. Second-and third-place plaques will awarded to those contestants who place second and third overall. Appropriate certificates will be awarded to any contestant who qualifies in any of the three speeds.
- The contestant who qualifies in the three above tests with the highest average of those contestants who reside in Illinois will be awarded the Sally J. Cochran Traveling Cup. In addition, the first-, second-, and third-place overall winners will receive a medallion memorializing Gary L. Sonntag, as well as a certificate. No transcript will be rated that has more than five percent of errors.
- 8. Transcribing: A printer will be provided for contestants to use in transcribing. Otherwise, equipment for transcription is the responsibility of the individual contestant. Contestants are responsible for producing their own transcripts without assistance from another person. Those who type must type their own transcripts; those who use computer-aided transcription must perform their own translating, editing, printing and proofreading functions.

In every sense, the contest transcripts must be the work product of the individual contestant. Any

- activities that call into question the integrity of a transcript may be reason for permanent disbarment from the Speed Contest.
- 9. Decisions: All decisions of the Speed Contest Committee and the ILCRA Board made under these rules, or such supplementary rules as may be found necessary at the time of the Contest, shall be final.
- 10. Continuing Education Credits: .4 CEUs are allowed by NCRA for each section of the speed contest in which the contestant qualifies. Qualification is based on transcription at 95% accuracy.

#### **ILCRA ANNUAL REALTIME CONTEST:**

TESTING CRITERIA: Five minutes of literary material dictated at 180 words per minute.

ELIGIBILITY: Any writer of shorthand who is a member of ILCRA in good standing and who has attained at least RPR, CBC, or CCP status.

> FINANCIAL INCENTIVES BARRED: Contestants must give to the committee satisfactory assurance that they have not received, directly or indirectly, any remuneration or promise of remuneration of whatever character for entering or winning any part of this const.

ENTRY FEE: Please register on <u>page 16</u>. The fee as stated on the registration form shall be paid by the registration deadline. Fee to be paid prior to contest.

- SEATING ARRANGEMENT: Seating shall be at the discretion of the chief examiner of the Realtime Contest.
- QUALIFYING: Only one transcription will be permitted of each test. 95% and higher qualifies. In order to qualify, contestant must write realtime into a computer and, without editing, at the direction of a testing monitor, create an ASCII/text file on a 3.5" diskette, CD, or jump/travel drive. Those unable to produce such a file on a disk, CD, or jump/travel drive within five minutes of such request may be disqualified, at the discretion of the contest chair. After verification of ASCII file, contestant will be required to delete all components of the file, including audio, from hard drive and recycle bin. Realtime may be in either ALL CAPS or mixed case. No transcript will be eligible for consideration with less than 95% accuracy.

AWARDS: Medals will be awarded for first, second and third place, and an appropriate certificate to those who attain 95% or higher. The contest committee will publish/announce only names of qualifying contestants.

CEUs: Per NCRA, qualifiers are eligible to receive .4 CEUs. An individual may only receive a maximum of .5 CEUs per 3-year NCRA cycle for any contests.

ALL COMMITTEE DECISIONS FINAL: The decisions of the committee made under these rules, or such supplementary rules as may be found necessary at the time of the contest, shall be final.

CONTEST MEDIA: All submitted disks, paper notes, and printed transcripts become the property of ILCRA and will not be available for participant review.

GRADING: Contestants will not be permitted to be present during the grading process. Transcripts will be marked for identification and corrected in such a manner that it will be impossible to know whose work is being examined until after the grading has been completed. A check-off list shall be maintained indicating the submission or non-submission of a disk from each contestant.

ERRORS: Errors shall be determined by the current "What is an Error?" handout of NCRA realtime skills testing.

Incorrect or missing punctuation: Tell me what you did sir. (half point off).

Incorrect capitalization: I telephoned Mrs. stone. (half point off).

Untranslates or phonetics that are probably readable (by a layperson): I had an ace of /HARTS. (half point off) But she had an ace of /TKAOEUPLDZ. (one point off) Her name was sinder ella. (half point off)


Wrong homophones: Did you eat the plumb? (half point off) I herd the doorbell ring. (half point off) Did you eat the /PHRUPL? (one point off)

Incorrect compounding or spacing: She grows roses in a regular green house. (half point off) The car would breakdown often. (half point off)

Word or words otherwise misspelled but can be deciphered or understood by a layperson: Did the rabbit eat the care ot? (half point off) Did the rabbit eat the indicator? (one point off)

Conflicts showing up will be a full point off: Was [there/their/they're] any cake left? (one point off) Yes, but [I/eye/aye] couldn't see how much. (one point off)

## **Lower Phone Bills**

By Gregg Marshall, CPMR, CSP

ou would think everyone has heard about VoIP, Voice Over Internet Protocol. It is advertised on TV by a number of companies, especially Vonage.

But apparently not. If your long distance bill is more than \$30, it might be worthwhile to investigate VoIP as a cost saving opportunity.

One option in VoIP is a service like Vonage, Broadvoice, etc. Most cable companies also offer "digital phone service" that is VoIP. And many regular phone services are coming up with VoIP options.

These services are typically in the \$20-30 per month range. They all include unlimited calls within the US, usually Canada, and some offer Europe (Broadvoice offers most of Western Europe and China in their package).

Unlike Skype, which requires your computer to operate, these services come with an adapter box (or they sell it to you for under \$100). That adapter box plugs into your cable or DSL modem and you

plug your computer or wireless router into them. You plug a regular telephone into the jack and you are ready to start calling. By putting the box between the modem and computer/router, they can ensure a better quality telephone connection despite your kids downloading the latest movies.

Vonage also has the slick V-Phone for traveling. It looks like a USB flash drive, which it is. But on one side is a small jack for a special cell phone headset. All the Vonage software is preinstalled. Just plug your V-Phone into a computer and start making and receiving calls. When you unplug the V-Phone it and all your call history/phone book go with you. That makes the V-Phone a great way to make calls using a hotel workstation or a computer at an Internet café. Load Migo's software (<a href="www.migosoftware.com">www.migosoftware.com</a>) on the flash drive and you can even take your desktop settings with you.

Many of these services can now transfer your existing telephone number to the service so no one will notice your switch to VoIP. Another plus is if you travel a lot, or have a summer cottage you stay at, you can take your adapter with you and your phone number stays the same no matter where you are in the world. You can even get a second telephone number in another area code (when my daughter was in Nova Scotia we got her Yak service that had a Nova Scotia number for friends at school and a 303 number for her friends in Colorado). Most of these services have voice mail and caller ID as standard options included in the monthly fee.

Watch ViaTalk's web sites. About every 60-90 days they'll do a buy one year, get one year free promotion. Sign up under that promotion and your average monthly bill drops below \$10 per month (\$199 for 2 years), although ViaTalk bills you an additional \$2.50 per month for regulatory fees recovery.

I recently switched my VoIP service to Ooma (www.ooma.com). They have a different business model than similar services such as Vonage. With Ooma you pay about \$250 for the adapter, which includes unlimited US calling for life. For less than \$10 per month you can upgrade to Ooma Premier which adds a second line and additional features. Calls outside the US are comparable to other VoIP services and Skype.

My experience with my VoIP service has been generally good and certainly less expensive than maintaining a regular telephone line and paying for long distance. I have, however, had instances of dropped calls or occasional drop outs (where the connection goes quiet for a few seconds before coming back).

## Forrest Gump v. The Prophet

n what ways does the proper use of a comma serve as an example of love, the elegant deployment of a semicolon an example of respect, or the graceful placement of dashes an example of esteem?

Kahlil Gibran (1883-1931), Lebanese-born poet, philosopher, and artist, in his work of timeless wisdom, *The Prophet*, spoke of the intimate relationship between work and love:

"What is it to work with love?" the Prophet was asked.

"It is to weave the cloth with threads drawn from your heart, even as if your beloved were to wear that cloth."

In court reporting, to weave the cloth is to produce a transcript; to do so with threads drawn from your heart is to make a loving, respectful investment in the preparation of that transcript; and to make such an investment is to produce your final product as though it were going to be presented as a gift to someone you love deeply and/or esteem highly. With the foregoing in mind, yes, the proper placement of a comma speaks, among other things, of love.

"It is to build a house with affection, even if your beloved were to dwell in that house."

The skills required for the professional preparation of a transcript can be likened to the skills required for the building of a house. The formatting of the transcript serves as your blueprint, the words on the pages serve as the foundation, and your certificate as the roof. If you build the house of your transcript as though your beloved were to live in that house, you will just as skillfully punctuate every transcript you produce as the consci-



## The Word 'However'

By Margie Wakeman Wells, College of Court Reporting

The word *however* can have different functions within a sentence. Depending on the function, punctuation differs.

RULE: Use a semicolon or period in front and a comma after the word *however* when it is used as the first word in a sentence. The word however here is called a conjunctive adverb and shows a relationship between the two sentences.

We saw them earlier; however, they did not attend the function.

She said she sent the e-mail on Friday; however, I did not get it.

Hank, Marty, and John helped. However, Mary, my sister, did not get well.

RULE: Use commas around the word *however* when it is in the middle of the sentence, and a comma in front of it when it is at the end of the sentence. In this instance, the word *however* is a parenthetical.

I did not see him, however, until later in the week.

My surgeon, however, did not inform me of the complications.

She had several responsibilities in the company, however.

RULE: Use a comma in front the word *however* when it is used to start a dependent clause that comes at the end of the sentence. Put commas around the clause if it is in the middle of the sentence.

I will stay, however long it might take.

He kept an eye on her, however engrossed he was in his work.

She discussed to speak out, however painful it might be, about the tragedy.

This construction is idiomatic in English. When *however* begins this type of clause, in addition to being the introductory word for the clause, it is functioning as an adverb to modify the word that follows it. The clause is said to be "loosely attached" to the content of the sentence and therefore needs punctuation. This clause often comes at the end of the sentence.
